Dear Parents and Students:

It is time to make arrangements for our annual orchestra trip. This year the orchestra will be traveling to Orlando, Florida.

The planned dates for the trip are: Wednesday, March 11, through Sunday, March 15, 2020.

Trip package includes:

- All-inclusive stay once on Disney property
- All airfare included
- All transportation included to and from airports, Universal, and Recording Studio
- All meals – breakfast, lunch, and dinner on property and in parks
- All hotel rooms included (on Disney Resort property) based on 4 students per room and 2 adults per room
- Paid security on duty at night
- Walt Disney World 3-day park hopper pass
- Walt Disney World recording studio experience and clinic
- Universal Studios pass (both parks)
- Disney Illumination Celebration Dinner
- Trip t-shirt and luggage tags
- Tour escort (Kim Hays, 817-528-8051)

The total cost of the trip is \$1650.00. Students will need to provide their own spending money and money for anything not listed above in the Trip Package.

We are looking forward to a great trip and hope that you will allow your son/daughter to participate. Read the attached form for specific financial arrangements. Please take special note of the payment due dates. These are particularly important on this trip. All payments must be made on time to maintain a spot on the trip roster. Failure to meet payment deadlines will result in removal from the trip and a loss of money paid.

Registration deadline is Friday, September 20, 2019. Please return the Permission/Financial form notarized by a notary public. A \$350.00 deposit or balance in the student account is required by **September 20** to process the trip registration. Students failing to meet the deadline will be placed on a waiting list, and may be added to the trip if space becomes available.

- We agree and understand that by **October 18, 2019**, a **\$700** credit (or more) must be in the L.D. Bell Orchestra student account for the named student. (This deposit is non-refundable).
- We agree and understand that by **November 22, 2019**, a **\$1050** credit (or more) must be in the L.D. Bell Orchestra student account for the named student. (This deposit is non-refundable).
- We agree and understand that by **January 24, 2020**, a **\$1350** credit (or more) must be in the L.D. Bell Orchestra student account for the named student. (This deposit is non-refundable).
- We agree and understand that by **February 21, 2020** the complete balance (\$1650.00) of the amount due for the trip must be in the L.D. Bell Orchestra student account for the above named student. (This deposit is non-refundable).

We understand that the completion and submission of this document obligates the above named student to pay the full balance due, non-refundable, regardless of the student's ability to participate in the trip for any reason. Due to the booking of hotels, transportation, and amusement activities – this is a non-refundable obligation.

Rules and Regulations

Please understand that in cases of severe infractions, at the discretion of the director or an administrator, students will forfeit their right to privileges and activities on the trip and be sent home at the parents' expense.
